Digital Citizenship Update

**Discussion** Brenda Anderson, Library Media Specialist and Digital Citizenship coordinator for Midvale Middle School, presented and discussed the Safe Technology and Digital Citizenship, A New Responsibility for School Community Councils.

Feb. 7th the school will hold an Internet Safety Assembly by the Attorney General's Office on how to be safe on the Internet.

The school does not have a lot of control over students cell phone use. Students are texting others in the school, if the school has grounds to search a phone they will. If a cell phone is disrupting the educational environment the school has the right to confiscate the phone, if it is justifiable. The school has policies in protocols in place to discipline students if needed when it comes to unsafe use of technology on school grounds. Midvale Middle School emphasizes that students should keep their information private, and not share logins with friends. If something happens when the student is logged in, they are responsible for it. Discussion of filters that the district uses as well as what we do when a student is able to bypass these filters.

SCC discussed the discussion questions. The SCC is comfortable with what the school is doing and appreciates the preventative measures the school/district is employing. SCC accepts the Digital Citizenship and Safe Technology Plan.

Budget Update Presenter: Wendy Dau

**Discussion** Midvale Middle School just held a 2 hour training on our CAYCI data. Much of the data deals with how safe students feel at school. Many of the safety issues are coming from bussing. Many of our parents and students believe that the students can go to college, but the teachers are not on the same level. The educators are seeing the skill deficit, and what needs to be done to get to college. Many of the students at MMS are in trauma. Many of these students have been exposed to adverse childhood effects. Midvale has been designated as a community school. The school has adopted a Care team to triage issues to meet the needs of our students. The teachers were paid to be here, so a couple thousand will come out of the budget. Money is still being used to pay the mentors. MMS was the first school in the district to become Level 1 Technology Certified. Money from the budget will be used to purchase a chromebook lab (40

chromebooks) for the world languages lab who was the first team to have all members become Level 1 Certified.
